Teaser	If your youth hunting license has been revoked by the issuing authority, you may reapply for it after the specified period of ineligibility has expired.
Volltext	If you wish to hunt in Germany, but you are not yet 18 years old, you can only be issued a youth hunting license in your name. If your youth hunting license has been withdrawn, you can apply for it again at the authority responsible for your place of residence after the specified restriction period has expired.

Voraussetzungen	• at least 16 and not yet 18 years old when issued • personal reliability • physical fitness • concluded hunting liability insurance • already issued youth hunting license withdrawn • consent of the legal guardian • elapsed blocking period

Verfahrensablauf	You can submit the application in writing or online, if available. If you submit the application in writing, fill it out and submit it by mail or in person to the competent authority. The application and the supporting documents to be submitted will be checked for completeness and correctness. If you meet all the requirements, you will be issued a youth hunting license.
Bearbeitungsdauer	
Frist	The youth hunting license is valid for a maximum of two consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03.
weiterführende Informationen	
Hinweise	The youth hunting license only entitles the holder to hunt in the company of a custodial person or a supervisor appointed in writing by the custodial person; the accompanying person must be experienced in hunting. The youth hunting license does not entitle the holder to participate in social hunts.
