Teaser	If your workshop card is about to expire, you must apply to renew it.
Volltext	The workshop card is a tachograph card that is issued to an authorized recording equipment manufacturer, installer, vehicle manufacturer or workshop. It identifies the card holder and enables the tachograph to be checked, calibrated and data downloaded. The workshop card is used by technicians at workshops authorized in accordance with § 57b StVZO who install and calibrate digital tachographs and by tachograph manufacturers. It is PIN-protected and valid for 1 year. When submitting the application, the workshop must be recognized or commissioned in accordance with § 57b StVZO and proof of training of the responsible specialist (technician) must be submitted. The documents must not be older than 3 years. The period of validity of the workshop follow-up card is 1 year. The competent body will renew the card within 15 working days of receipt of the application and submission of all required documents.

Voraussetzungen	Workshops recognized and authorized in accordance with § 57b StVZO, manufacturers of tachographs and vehicle manufacturers are eligible to apply.

Verfahrensablauf	 Depending on the federal state, you can submit the application to renew your workshop card with the required documents and information online or on site. At your local driving license authority or another competent authority (e.g. TÜV, DEKRA). To identify yourself online and check your documents, you must have the option of online authentication via a company account and digital upload of the required documents. You can pay for the application online via a payment service provider. The creation of a workshop card is subject to a fee. As part of the application process, you must provide all the required information and submit or upload documents. The responsible office will check your details for completeness and accuracy. The personalized workshop card will be issued to the company against confirmation of receipt. The required identification number (PIN number) will be sent directly to the responsible specialist at the private address provided.
