You can use the register portal without registering and free of charge. You have the option of entering keywords or register numbers to search specifically for registered companies, for example. Alternatively, you can request a printout from the electronically managed registers from the register court. If you do not provide any information, you will receive a current official printout from the commercial, cooperative and partnership register. For the register of associations, you will receive an unofficial, up-to-date printout. Printouts can also be sent to you electronically if you specify this in your application. |
