Teaser	If the validity of your day hunting license for foreign youngsters expires or has already expired and you wish to continue hunting, you must have it extended.
Volltext	If you would like to hunt in Germany but are not yet 18 years old, you can only be issued a foreigner's youth hunting license in your name. If you already have an annual hunting license but its validity has expired, you can apply for an extension.

Voraussetzungen	• at least 16 and not yet 18 years old at the time of issue • personal reliability • physical fitness • completed hunting liability insurance • Youth hunting license already issued • consent of the legal guardian

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority.

	The application and the supporting documents to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued with a youth hunting license for foreigners.
Bearbeitungsdauer	
Frist	The annual hunting license for young people is valid for a maximum of two consecutive hunting years. A hunting year begins on 01.04. and ends on 31.03. of each year.
weiterführende Informationen	
Hinweise	The youth hunting license only entitles you to hunt when accompanied by a person with parental authority or a supervisor appointed in writing by the person with parental authority. The accompanying person must be experienced in hunting. The youth hunting license does not entitle you to participate in group hunts.
