Volltext	If you are a foreign national and wish to hunt in Germany, you will need a German falconry hunting license and hunting permit in your name. If you are already in possession of these hunting licenses as annual hunting licenses but their validity has expired, you can apply for an extension.

	The application and the supporting documents to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a foreigner falconry hunting license.
