Teaser	If you employ trainees as an employer, you must enter their vocational training in the register of vocational training relationships and update or amend it as required.
Volltext	<p>The register of vocational training relationships is kept by the bodies responsible for training (e.g. Chamber of Industry and Commerce, Chamber of Crafts, other professional chambers). It contains all recognized training occupations and records all essential contents of the vocational training contract.</p> <p>If there are any changes after registration, you as the training provider can submit an application for changes to the regional competent authority. The competent authority will check the legality of the change and then confirm the change to the vocational training contract.</p> <p>Changes can also concern, for example, changes in weekly working hours, such as a change from full-time to part-time and vice versa, or a change of specialization or change of address.</p>

Voraussetzungen	<ul style="list-style-type: none"> • The vocational training relationship has already been registered. • The contract complies with the Vocational Training Act (BBiG) and the training regulations. • For underage trainees: Consent of the legal representatives
Kosten	<p>Gebühr: 0€ - 100€</p> <p>The change may be subject to a fee for you as a training center. The fee is based on the respective fee regulations of the regional authorities responsible.</p>
Verfahrensablauf	<p>As the training provider, you submit the application for the change to the responsible office in analog or electronic form.</p> <p>The competent body will check the relevant data and documents in accordance with the Vocational Training Act and record them in the register of vocational training relationships.</p> <p>During the change, the training contract and training plan, for example, can be checked again with regard to the legal requirements, as well as the training center with regard to suitability for training.</p> <p>If necessary, the responsible office will contact you for the following reasons:</p> <ul style="list-style-type: none"> • Queries • Additional requests for documents

	<ul style="list-style-type: none"> • Correction of deficiencies <p>At the end of the procedure, you as the trainer will receive a corresponding notification from the competent body as to whether the change has been made or rejected.</p>
