Teaser	As a resident, you can take part in your municipality's residents' question time.
Volltext	As a resident, you have the opportunity to ask questions during residents' question time at public meetings of the municipal council and its decision-making committees. These questions relate to the affairs of the municipality and, if regulated locally, to the topics to be discussed at the public meeting. Your local council may also allow residents' question time at public meetings of advisory committees. In addition, as a resident of the local authority, you can take part in the residents' question time at public meetings of the local council and its decision-making committees and ask your questions on matters relating to the local authority.
Erforderliche Unterlagen	If necessary, the meeting committee will check your identity as a resident of the municipality or locality. It is therefore advisable to have proof of identity with you.
Voraussetzungen	You live in the relevant municipality or town.
