Please use the "Proof of use" form provided for this purpose. This is available online in the ELAISA portal.</li> <li>Send the proof of use with the required evidence to the Office for Agriculture, Land Consolidation and Forestry (ALFF) Anhalt by June 30 of the following year at the latest.</li> <li>After the proof of use has been checked by the granting authority, you will receive an audit notification certifying that the funds granted have been used properly, provided that no objections were found as a result of the audit. If necessary, documents relevant to the audit may be requested.</li> <li>If funding is not used on time or not used for the intended purpose or not used in full, the funding will be reclaimed accordingly.
