Volltext	<p>If there are facts indicating that</p> <ul style="list-style-type: none"> <li>• an asset associated with a business relationship, brokerage or transaction originates from a criminal offense that could constitute a predicate offense to money laundering</li> <li>• a business transaction, a transaction or an asset is related to terrorist financing, or</li> <li>• the contracting party has not fulfilled its obligation to disclose to the obliged entity whether it intends to establish, continue or carry out the business relationship or transaction for a beneficial owner, the obliged entity must immediately report this fact to the Financial Intelligence Unit (FIU), irrespective of the value of the asset concerned or the amount of the</li> </ul>
