Teaser	If you have passed the final examination, you can apply for a duplicate or translation of the examination certificate. You can also request a list of your vocational school achievements on the examination certificate.
Volltext	<p>If you are a trainee completing dual training in a recognized training occupation, you will take a final examination at the end. After passing the examination, you will receive an examination certificate. If a two-part extended final examination takes place, you will also be informed of the result of the examination performance from the first part of the extended final examination.</p> <p>As a trainee, you can apply for a duplicate of the examination certificate. You can also request an English and/or French translation. If you would like the result of your vocational school performance to be listed on the certificate, you must submit an application to the relevant office.</p>
