Teaser	As the training provider, you must enter every training contract for a recognized training occupation in the vocational training register and have it deleted in the event of premature termination.
Volltext	The register of vocational training contracts is kept by the bodies responsible for training, for example the Chamber of Industry and Commerce, Chamber of Crafts and other professional chambers. It contains all recognized training occupations and records all essential contents of the vocational training contract. After a training contract has been terminated, you as the training provider must submit an application for deletion to the competent regional authority. The competent authority checks the legality of the deletion and then confirms the deletion of the vocational training relationship.

Voraussetzungen	You have had a vocational training contract entered in the register of vocational training relationships.
Kosten	Abgabe: 0€ - 100€ Deletion may be subject to a fee for you as a training center. The deletion fee is based on the respective fee regulations of the regional authorities responsible.
Verfahrensablauf	As the training provider, you apply for deletion from the register of vocational training relationships in analog or electronic form to the competent authority.
	The competent body will check the relevant data and documents in accordance with the Vocational Training Act and enter them in the register of vocational training relationships.
	If necessary, you as the trainer will be contacted by the competent body for the following reasons:
	<ul> <li>Queries</li> <li>Subsequent requests for documents</li> <li>Correction of deficiencies</li> </ul>
	At the end of the procedure, you as the training provider will receive a corresponding notification or a decision from the competent authority as to whether the deletion has been carried out or rejected.
Bearbeitungsdauer	4 Woche(n) Depending on the documents submitted, the process usually takes up to 4 weeks.
Frist	You must submit the application immediately after termination of the vocational training relationship.

Kurztext	<ul> <li>Register of vocational training relationships according to BBiG Deletion</li> <li>Trainees in training occupations under the BBiG are entered in the register of vocational training relationships.</li> <li>If the training relationship is terminated prematurely, the training center applies for the entry to be deleted.</li> <li>Deletion is carried out if the entry requirements are not met or if the medical certificate for the first follow-up examination is not available when registering for the intermediate examination or the first part of the final examination.</li> <li>Responsible body: Chambers</li> </ul>
Ansprechpunkt	<ul> <li>Contact the chamber responsible for your vocational training. This can be</li> <li>the Chamber of Industry and Commerce for vocational training in non-trade professions,</li> <li>the Chamber of Agriculture for vocational training in agricultural and rural domestic professions</li> <li>the Chamber of Lawyers, Patent Attorneys and Notaries as well as the Notary's Office for the vocational training of specialists in the field of law,</li> <li>the Chamber of Auditors and the Chamber of Tax Consultants for the vocational training of professionals in the field of auditing and tax consultancy,</li> <li>the Chambers of Physicians, Dentists, Veterinarians and Pharmacists for the vocational training of healthcare professionals.</li> <li>There are other competent bodies, for example for bodies in the area of public law and the churches.</li> </ul>
