Teaser	If you are a doctor and would like to apply for authorization to examine persons exposed to radiation, you can obtain this authorization from the competent authority under certain conditions.
Volltext	As an authorized physician, you have the task of carrying out medical examinations in accordance with the Radiation Protection Ordinance as well as special medical supervision. You keep a health record for each person who is subject to your medical supervision.

	documents, unless these documents are already available to the competent authority. The authority will review the application and decide whether to grant the authorization. If the application is approved, the authorization will be sent and the administrative fees will be charged.
Bearbeitungsdauer	The processing time depends on the scope of the review and the completeness of the application.
Frist	5 Jahr(e) Authorization under the Radiation Protection Ordinance is limited to five years.
