Teaser	If you wish to hand over firearms, ammunition, firearms or ammunition at public festivals, shooting festivals or similar events, in the context of a shooting range or orders for weapons and ammunition at trade fairs, you must apply for an exemption permit.
Volltext	The provision of firearms, ammunition, cutting or thrusting weapons is generally prohibited. In exceptional cases, however, this is permitted with a permit. This is permitted under certain circumstances at public festivals, shooting festivals or similar events, as part of a shooting range or when ordering weapons and ammunition at trade fairs. You will need a permit for this.

Kurztext	• Exemption from prohibitions on the transfer of firearms, ammunition, blunt or edged weapons - Approval • In principle, the transfer of firearms, ammunition, cutting weapons or impact weapons is prohibited • In exceptional cases, however, this is permitted, e.g. the acceptance of orders at trade fairs or exhibitions, or the transfer at public festivals, shooting festivals as part of a shooting range • The exception must be applied for with the competent authority • Competent authority: Depends on the respective state law
