Teaser	If you want to run a riding or driving business, you need a permit from the relevant authority. You can find out more here.
Volltext	The requirements for the commercial operation of a riding or driving business are generally met if more than one animal is regularly made available for riding and driving purposes in return for payment. This also applies to riding clubs that not only provide horses for their members, but also regularly provide horses to third parties for a fee. Permission is also required to offer pony rides, trail rides, carriage rides, covered wagon rides and therapeutic riding.
Erforderliche Unterlagen	• Identity document • Certificate of good conduct • Proof of expertise, certificates • Sketch or construction drawings, plan documents of the premises or facilities
Voraussetzungen	In order to obtain a permit, you must generally provide proof of your expertise in handling the respective animals and your reliability. In addition, the permit and the requirements are tailored to the individual case. The rooms and facilities used for the activity must enable the animals to be fed, cared for and housed in accordance with the legal requirements.
Kosten	Depends on the administrative fee schedule of the respective federal state.
