Teaser	If you wish to train dogs for third parties on a commercial basis, you will require a permit from the competent authority. You can find out more here.
Volltext	The activity of commercially training dogs for third parties and guiding dog owners in the training of dogs (dog trainers, dog therapists, dog psychologists) requires a permit from the competent authority. The granting of a permit is intended to ensure that persons who train dogs commercially or who commercially instruct the training of dogs by the animal owner have the necessary specialist knowledge and skills based on their training or their previous professional or other dealings with animals.
Erforderliche Unterlagen	• Identity document • Certificate of good conduct • Proof of expertise, certificates • Sketch or construction drawings, plan documents of the premises or facilities
Voraussetzungen	In order to obtain a permit, you must generally provide proof of your expertise in handling the respective animals and your reliability. In addition, the permit and the conditions are tailored to the individual case. The expertise required for the activity can generally be assumed if the person responsible has completed state-recognized or other training or further training that qualifies them to handle the animal species
