Teaser	If you trade in breeding cattle and/or livestock or wish to attend an exhibition or similar event with breeding cattle and/or livestock, you will need a health certificate.
Volltext	If you trade in breeding cattle and/or livestock or wish to attend an exhibition or similar event with breeding cattle and/or livestock, you require an official veterinary health certificate. In this certificate, you must confirm that your stock of breeding and productive cattle is free from certain diseases. As a rule, this concerns freedom from tuberculosis, brucellosis and leukosis, possibly also bluetongue and infections with the bovine herpes virus.
Erforderliche Unterlagen	The documents vary from case to case and are updated regularly. Please contact the locally responsible authority
Voraussetzungen	• Your herd of breeding and productive cattle is free from tuberculosis, brucellosis and leukosis and, where applicable, free from BHV1 infections and bluetongue.
Kosten	The fees depend on the individual case.
Verfahrensablauf	• Applications are usually made in writing to the competent veterinary office. In some cases there are

Hinweise	The health certificates are proof for individual animals that they are free from a disease. The aim is to maintain the freedom from a disease on a holding, in a region or in a Member State.
Rechtsbehelf	Appeal (appeal may be excluded depending on state law), administrative court action
Kurztext	• Health certificate for the trade in breeding and productive cattle and the participation of these animals at exhibitions • The health certificate for the trade in breeding and production cattle and their participation in exhibitions and similar events must be applied for from the competent authority • The health certificate must be applied for in writing by the applicant. Competent authority: depends on the respective state law
