Volltext	Anyone wishing to operate a livestock trading business aimed at buying cattle, pigs, sheep, goats, horses or poultry on a commercial basis directly or via third parties and reselling them within 30 days of purchase or transferring them to another farm or facility requires approval from the competent authority Approval is not required if the animals referred to above are merely brokered between buyer and seller.
