Teaser	Do you have additional costs due to your visual impairment? Find out here about your entitlement to blindness benefit.
Volltext	If you are blind or severely visually impaired, you may be entitled to blindness benefit. It is intended to compensate for your additional expenses due to your disability. From 01.07.2025, the allowance for blindness will be up to 460.44 euros per month for adults and up to 319.76 euros per month for minors. The severely visually impaired will receive 66.50 euros per month. Benefits under the State Blindness Benefit Act are independent of income and assets. However, some care insurance benefits are offset against the allowance for the blind. For example, if you receive cash or non-cash benefits for home care or partial or full inpatient care, you will receive less allowance. This is how much money you will receive: If you are cared for at home: • Care level 2 Adults: 279.08 euros Children and young people: 149.40 euros • Care level 3 to 5 Adults: 244.59 euros Children and young people: 114.91 euros If you live in a care home: • If you pay more than half of the care home costs yourself: Adults: 424.44 euros Children and young people: 294.76 euros • If you pay less than half of the home costs yourself: Adults: 212.22 euros Children and young people:

Erforderliche Unterlagen	• Application for blindness benefit • Assessment notice in the law on severe disabilities for blindness or severe visual impairment
Voraussetzungen	You can receive blindness benefit if you meet one of the following requirements: 1. You are blind. 2. You have another severe visual impairment, that is so severe that it is as bad as blindness. 3. You are severely visually impaired. 4. You have another severe visual impairment, that is just as severe as a severe visual impairment. You are considered severely visually impaired if your visual impairment is so severe that it causes a degree of disability of 100 - but you are not yet blind.

Frist	The allowance for the blind will be paid to you from the month in which the requirements are met and your application has been submitted to the State Administration Office.

Hinweise	In contrast to the allowance for the blind, assistance for the blind is a federal benefit. You can receive this in addition to the allowance for the blind. You can find out which requirements must be met from your local social welfare office. Kurztext	- blind or severely visually impaired persons are granted a blind person's allowance to compensate for additional expenses upon application - their place of residence must be in Saxony-Anhalt - for blind adults up to EUR 460.44, for minors up to EUR 319.76 - EUR 66.50 for severely visually impaired persons - No deduction of income/assets - Offsetting of care services
