Teaser	In general, all children and young people living in Saxony-Anhalt are required to attend school. However, there are exceptions that put compulsory schooling on hold.
Volltext	<p>School attendance is compulsory for all children and young people living in Saxony-Anhalt. For children who reach the age of 6 by 30 June, it begins with the following school year and ends after 12 years. The statutory compulsory education of 12 years is fulfilled by attending a vocational school, unless a general education school is still attended.</p> <p>Compulsory schooling may be suspended under certain conditions.</p>
Erforderliche Unterlagen	<p>The required documents are different.</p> <p>The following documents are required if required:</p> <ul style="list-style-type: none"> <li>• Proof that you have become parents</li> <li>• Medical records</li> <li>• Proof of participation in a pre-vocational training measure or in an entry-level qualification</li> <li>• Proof of planned participation in a voluntary service</li> <li>• Proof of attendance at a vocational school for health professions</li> <li>• Certificate of enrolment</li> <li>• Proof of other appropriate training or supervision</li> </ul>
Voraussetzungen	<p>Compulsory education is suspended if:</p> <ul style="list-style-type: none"> <li>• you are a mother or father and are prevented from</li> </ul>

	<p>caring for your child adequately by attending school,</p> <ul style="list-style-type: none"> <li>• your child is unable to attend school or attend special education for health reasons,</li> <li>• you participate in pre-vocational training measures or in an introductory qualification in accordance with the Third Social Security Code,</li> <li>• you participate in voluntary service under federal or state law,</li> <li>• you attend a vocational school for health professions to which the Saxony-Anhalt School Act does not apply,</li> <li>• you are enrolled at a university or</li> <li>• In cases where other appropriate training or supervision appears to be assured.</li> </ul>
Kosten	Fees may apply. It depends on the individual case.
Verfahrensablauf	<p>The procedure is different.</p> <ul style="list-style-type: none"> <li>• As a school-age mother or father, you must submit an application. If you are still a minor, you will need the consent of your legal guardian.</li> <li>• If your child is unable to attend school or attend special education for health reasons, you must submit an application as a parent or guardian.</li> <li>• If you are taking part in a vocational preparation training measure or in an introductory qualification according to Book III of the Social Code, you must inform us of this.</li> <li>• If you participate in volunteer service due to federal or state regulations, you must notify us.</li> <li>• If you attend a vocational school for health professions that are not subject to the Saxony-Anhalt School Act, you must notify us.</li> <li>• If you are enrolled at a university, you must submit an application. If you are still a minor, you will need the consent of your legal guardian.</li> <li>• In cases where other training or supervision appears to be assured, this must be reported.</li> </ul>
Bearbeitungsdauer	up to 4 weeks
Frist	<p>4 weeks before compulsory schooling is to be suspended, proof must be provided if:</p> <ul style="list-style-type: none"> <li>• is to be taken part in a pre-vocational training measure or an entry-level qualification,</li> <li>• the school-age employee</li> </ul>
