All essential contents of the vocational training contract are entered in this register.</p> <p>If you as an employer have concluded a vocational training contract with a trainee, you are legally obliged to apply for entry in the register of vocational training relationships.</p> <p>The following are entered in the register</p> <ul style="list-style-type: none"> <li>• Surname, first name, date of birth and address of the trainee</li> <li>• Gender, nationality, general school-leaving qualification, previous participation in pre-vocational training or basic vocational training, previous vocational training</li> <li>• if required, surname, first name and address of legal representative(s)</li> </ul>

<b>Verfahrensablauf</b>	<p>Submit the application to the Chamber of Tax Consultants responsible for your company once the training contract has been concluded.</p> <p>The entry in the register will be cancelled if the medical certificate for the first follow-up examination is not submitted by the day the trainee registers for the intermediate examination or the first part of the final examination at the latest.</p>
