Volltext	<p>If you are temporarily unable to run the household yourself due to pregnancy or childbirth and no family member is able to do this work, you can apply for support from a home help.</p> <p>The health insurance fund will either send you a replacement or reimburse you for a reasonable amount if you employ someone yourself. Before you employ someone, you should find out in advance from your statutory health insurance company what benefits you can receive.</p> <p>Note: Most statutory health insurance companies work together with appropriate organisations and provide a replacement. If in doubt, you should therefore enquire with your private health insurance company.</p>
