Erforderliche Unterlagen	• Identity card or passport with current confirmation of registration (alternatively, a current confirmation of personal data by the registration office) • official driving licence or, after leaving the service, a certificate of former possession of the official driving licence • civilian driving licence (if available) • biometric photo • when applying for a driving licence for categories C, C1, C, CE additionally: certificate of a general medical examination (not older than one year at the time of application) certificate of medical examination of eyesight or, if applicable, a certificate from an ophthalmologist (not older than two years at the time of application) • in the case of an application for a driving licence for categories D1, D1E, D, DE additionally: certificate of a general medical examination (not older than one year at the time of application) certificate of medical examination of eyesight or, if applicable, a certificate from the ophthalmologist (not more than two years old when application is made) occupational or occupational medical certificate or certificate from an officially recognised assessment centre for driving aptitude (not older than one year when application is made)
