Verfahrensablauf	<ul> <li>You can apply for benefits from the "Hilfe für Familien, Mutter und Kind" foundation at one of the points of contact listed above. There you will also receive personalised advice and help with completing the application.</li> <li>You can obtain the applications from the respective points of contact.</li> <li>Describe the emergency situation in the application and explain your income and financial circumstances.</li> <li>State what other assistance has already been utilised or to what extent you have tried to do so.</li> <li>With your signature, you confirm the accuracy of the information you have provided and give written authorisation for your details to be checked.</li> <li>You submit the application together with the necessary supporting documents to the point of contact. The information will be checked there and your documents will be forwarded to the Foundation's head office with a corresponding decision proposal.</li> <li>The Foundation's office will inform you in writing whether and to what extent your application has been approved and will pay out the funds.</li> </ul>
