Volltext	<p>Appointment of a general representative for tax consultants in accordance with Section 69 of the Tax Consultancy Act (StBerG)</p> <p>If you as a tax consultant* or tax agent are prevented from practising your profession for longer than one month, you must appoint a general representative.</p> <p>At your request, the competent Chamber of Tax Consultants will appoint the general representative for you. The competent Chamber of Tax Consultants can arrange for the appointment of a general representative ex officio if you have failed to appoint a general representative or to apply for the appointment of a general representative. The representative must be a tax consultant or authorised tax representative.</p> <p>Single point of contact</p> <p>You can use the service of the Single Point of Contact for this procedure.
