<b>Erforderliche Unterlagen</b>	<ul style="list-style-type: none"> <li>• Certificate that they are legally established in a member state of the European Union, another state party to the Agreement on the European Economic Area or Switzerland for the preparation of stability certificates and that they are not prohibited, even temporarily, from carrying out these activities at the time of submission of the certificate</li> <li>• Proof that they had to fulfil at least the requirements of Section 66 (2) in the country in which they are established in order to work as a qualified structural engineer</li> </ul> <p>You can find out which other documents you need to submit with your application from the Ingenieurkammer Sachsen.</p>
