|                          | Depending on your income and assets, from 1 January 2025 you will receive a monthly amount of up to EUR 297.00 for each child for whom you are entitled to child benefit. This can prevent your family from having to rely on supplementary income support just because of the children.   |
|                          | The following points are used to calculate your income:  |
|                          | <ul> <li>Your child's income, for example maintenance, maintenance advance or half-orphan's pension, at 45 per cent,</li> <li>45 per cent of your income from employment and self-employment that exceeds your own needs,</li> <li>Income replacement benefits, for example unemployment benefit or sickness benefit,</li> <li>Parental or state child-raising allowance,</li> <li>Pensions from social insurance,</li> <li>Capital and interest income,</li> <li>Income from letting and leasing,</li> <li>Maintenance payments (spousal maintenance).</li> </ul> |
