This does not apply to performances of a predominantly artistic, sporting, acrobatic or similar nature (Section 33a (1) sentence 2 GewO).</p> <p>Single Point of Contact (Einheitlicher Ansprechpartner)</p> <p>For this procedure, you can use the service of the Single Point of Contact. They will guide you through the administrative procedure, take care of correspondence with all the offices responsible for your request and will be available to you as a competent advisor.</p> |

| Verfahrensablauf             | <p>You can apply for a permit for the exhibition of persons in person, in writing or electronically to the competent authority.</p> <p>The authority can issue the permit with a time limit and link it with conditions for the protection of</p> <ul style="list-style-type: none"> <li>• the general public,</li> <li>• guests or</li> <li>• neighbors.</li> </ul> <p>Under the same conditions, the subsequent inclusion, amendment and addition of conditions is also permitted.</p>                       |
| Bearbeitungsdauer            | Application processing and decision: within 3 months after receipt of the complete documents.                                                                                                                                                                                                                                                                                                                                                                                                                  |
| Frist                        | You must apply for the permit before starting the activity.
