Infants and children also receive their own card. The electronic residence permit (eAT) has a contactless chip inside the card.</p> <p>It stores</p> <ul style="list-style-type: none"> • biometric features (photo, from the age of six two fingerprints), • Ancillary provisions in connection with the residence title (e.g. conditions) and personal data • personal data. <p>The card offers you electronic proof of identity and a qualified electronic signature (electronic signature function) as additional functions. The competent authority can switch these functions on or off at your request.</p>

If available for your place, submit your application online via Amt24 (see -> Online application and forms).</p> <p>Applying in person</p> <ul style="list-style-type: none"> • If the application can only be submitted in person, arrange an appointment with the Aliens' Registration Office. • During the appointment, your application will be accepted and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuing of the electronic residence permit (eAT). <p>Online application</p> <ul style="list-style-type: none"> • Call up the online application via Amt24. If you do not yet have a service account in Amt24, set up your access in the further course. • The electronic application wizard will help you fill out

	<p>the forms.</p> <ul style="list-style-type: none"> • After you have submitted your application, it will be registered and checked. This may take a few weeks. You will receive a notification with further information as soon as this process is completed.
