Verfahrensablauf	<p>Contact the Department 31, School Psychology of the State Office for Schools and Education responsible for your school district by telephone or in writing (-> responsible office).</p> <p>You can also ask teachers, counselling teachers, the school management or the staff of the locations to arrange an appointment and to provide support.</p> <ul style="list-style-type: none"> • Agreement on a confidential discussion • Discussion only between the pupil and the school psychologist; if necessary and with agreement, teachers, the school administration or staff of the locations can be consulted • Counselling may also include psycho-diagnostic examinations, e.g. of perception, concentration, memory, intelligence and the development of personality traits. • subsequently, joint counselling on possible solutions and further steps, if necessary, further treatment by a doctor or therapist
