Erforderliche Unterlagen	• Form "Application for granting/modification of an authorization as repairer according to § 54 MessEV" (Further information "Applications and forms") • Certificates of competence for authorized personnel: Training certificates from the manufacturers or distributors authorized by them. In order to be able to assess the application, further information and documents may be required as proof under certain circumstances.
Voraussetzungen	Companies that repair and adjust calibrated measuring instruments are eligible to apply. They must meet the following conditions: • The establishment is equipped with the facilities and skilled personnel required for repair and adjustment. • Suitable and traceable test equipment must be available for checking the repair.
Kosten	The fees and expenses are based on code number 14.5.1.1 of the fee schedule of the Ordinance on Measurement and Calibration Fees (MessEGebV).
Verfahrensablauf	You apply for the authorization to use a repairer's mark on the prescribed application form at the Weights and Measures Office. • Please fill out the form completely and gather the necessary evidence. • Submit the application documents to the above-mentioned office. • The Saxon State Office for Metrology and Verification will check your application. If it is approved, you will be issued with a certificate of authorization and the repairer's mark.
