### **Amount**

• Subsidy per training group week and participant: EUR 150.00 (A training group week is based on five training group days, which do not have to be completed consecutively. However, only full participant weeks are funded. If no full participant weeks are completed, the funding is rounded down to the full participant week)

## Voraussetzungen

Eligible to apply

• Companies (natural or legal persons, associations of persons) with up to 500 employees with their registered office or branch in the Free State of Saxony which send trainees to the association partner within the framework of the training contract

Further requirements

Funding is possible if

- the training is in the form of in-company vocational training.
- the vocational training is carried out in recognised training occupations according to the Vocational Training Act (Berufsbildungsgesetz) or the Crafts Code (Handwerksordnung) and the training course complies with the requirements of Section 1 (3) of the Vocational Training Act (BBiG).
