Kosten	Procedural fee according to BAM cost regulation (BAMBGebV)
Verfahrensablauf	Send an informal letter with the required information / evidence on the explosive to the Federal Office for Materials Research and Testing (BAM). Processing via the Single Point of Contact Since this is a technically very demanding procedure and technically complicated information has to be exchanged in individual cases, it is only expedient to process the application directly at the Federal Institute for Materials Research and Testing (BAM). The point of single contact should therefore only refer to the Federal Institute. Detailed questions are to be clarified between the applicant and BAM.
