This certificate must be submitted to the Bar every year. If you fail to comply with this obligation, your admission to the Bar will be revoked.</p> <p>When using your professional title, you must state your country of origin in German. After admission, you may practise in the law of your country of origin or in the field of international law.</p> <p>### Single Point of Contact</p> <p>For this procedure, you can use the services of the Single Point of Contact. He or she will accompany you through the procedure, take care of the correspondence with all the offices responsible for your matter, and will be at your side as a competent</p>
