<b>Voraussetzungen</b>	<ul style="list-style-type: none"> <li>• Test engineers for fire protection who are recognised in the Free State of Saxony can apply to set up an additional branch.</li> <li>• Authorisation will be granted if there are no objections to the proper performance of duties as a test engineer.</li> </ul>

Verfahrensablauf	<p>Submit an informal application for authorisation of an additional branch with the required documents to the competent authority.</p> <p>You will receive a written confirmation of receipt; the recognition authority will request any missing documents.</p> <ul style="list-style-type: none"> <li>• If the additional establishment is to be set up in another country, the recognition authority of the other country will be asked for approval.</li> <li>• If all requirements are met, the recognition authority will issue an authorisation.</li> </ul>
