Volltext	Notification in accordance with § 192 of the German Social Code, Seventh Book (SGB VII) Start-ups You must register your future company with the statutory accident insurance institution responsible for your sector within one week of starting self-employment. In the case of companies, organisations and freelancers, the law stipulates that this is the commercial employers' liability insurance association, unless responsibility lies with the agricultural employers' liability insurance association or the public sector accident insurance institutions. You need the membership number of your accident insurance institution and the associated categorisation into hazard classes in order to register employees for social insurance. As a member, you can also obtain advice on occupational health and safety issues when setting up your business premises.
