Verfahrensablauf	<p>If you have any questions regarding the application and insolvency proceedings in general, please contact the judicial officer at the competent insolvency court.</p> <ul style="list-style-type: none"> • You apply for a deferral of the costs of the proceedings in connection with the application for discharge of residual debt. • You can obtain paper forms for the application from the court or from the collection of forms (see under the heading "Further information"). • Submit the completed and signed form to the competent court. • The court will examine the application and inform you of the decision in writing. <p>Note: The deferral is granted separately for each stage of the proceedings and must be applied for separately.</p> <p>Repayment</p> <p>Repayment of the deferred amounts begins after the insolvency proceedings, when residual debt discharge is granted.</p> <ul style="list-style-type: none"> • If you are unable to pay the outstanding amount in full or in part, an extension is possible upon your renewed application. • The court can set monthly instalments for repayment. A maximum of 48 monthly instalments must be paid. <p>Note: The court will adjust the deferral to your personal and financial circumstances - please report any changes immediately and without being asked.</p>
