Teaser	If you would like to work in the field of medicine in Germany, you need a medical licence (Approbation) or a licence in accordance with the Heilpraktikergesetz (HeilprG).
Volltext	If you would like to work in the field of medicine in Germany, you need a medical licence (Approbation) or a licence in accordance with the Heilpraktikergesetz (HeilprG). Heilpraktiker in the field of psychotherapy is not a regulated training profession. There is therefore no state final examination. In order to obtain the "Small Heilpraktiker Psychotherapy Licence", you must fulfil legally defined minimum requirements and generally undergo a knowledge check by the public health department.
Erforderliche Unterlagen	<ul> <li>Application form</li> <li>if the competent body does not have an application form available: informal application for authorisation to practise medicine professionally without a licence in accordance with the Heilpraktikergesetz in the field of psychotherapy</li> <li>brief curriculum vitae with photograph</li> <li>Birth certificate</li> <li>for married persons / civil partners: marriage certificate / civil partnership certificate</li> <li>Identity card or</li> <li>Passport or</li> <li>in cases of doubt: Certificate of citizenship</li> <li>a certificate ("Meldebestätigung") that the applicant is resident in the Free State of Saxony. The certificate must not be older than three months at the time of application.</li> <li>official certificate of good conduct of document type "O". The certificate of good conduct must not be older than three months at the time of application.</li> </ul>

	<ul> <li>Declaration as to whether criminal proceedings before a court or a public prosecutor's investigation are pending</li> <li>medical certificate stating that the applicant is medically fit to practise as a non-medical practitioner. The certificate must not be older than three months at the time of application</li> <li>School-leaving certificate (certified copy)</li> <li>Declaration as to whether and, if applicable, to which authority a licence in accordance with the Heilpraktikergesetz has previously been applied for</li> <li>Declaration that you wish to work exclusively in the field of psychotherapy</li> <li>Proof of previous training and further education</li> <li>employment references, if applicable</li> <li>Only for applicants outside the European Economic Area (EEA):</li> <li>Residence permit</li> <li>if the medical profession is to be practised as a non-self-employed activity: Work permit</li> </ul>
Voraussetzungen	<ul> <li>The applicant <ul> <li>has reached the age of 25</li> <li>has his/her place of residence in the Free State of Saxony</li> <li>has completed at least secondary school or can provide evidence of comparable training</li> <li>is morally reliable and has not committed any serious criminal or moral offences</li> <li>is suitable for practising the profession of alternative practitioner in terms of health</li> <li>successfully completes the knowledge check (in certain cases, the knowledge check may be waived and a decision made on the basis of the file)</li> </ul> </li> </ul>

	<ul> <li>out whether the competent authority has application forms available. Depending on what the authority offers, you can also download the application form from Amt24 (-&gt; Online application and forms).</li> <li>Compile all the necessary supporting documents (see "Required documents") and submit them to the competent authority with your application. If necessary, the responsible office will request further documents from you.</li> <li>If the documents are complete and all requirements are met, the responsible regulatory office will forward the application to the health authority of the district of Görlitz for a knowledge check.</li> <li>All candidates from Saxony take the knowledge test on the specified date at the Görlitz district health authority. The written part is taken in Zittau, the oral part in Löbau.</li> <li>Please have the notification from the health authority and your valid identity card or passport ready for the examination date.</li> <li>You will receive written confirmation of the result of the examination and a fee notice.</li> <li>If you have fulfilled the requirements, the public order office will send you the licence certificate as soon as you have paid the administrative fee.</li> <li>The licence authorises you to practise psychotherapy exclusively.</li> <li>To be legally certain, only use the designation stated in the licence certificate.</li> <li>If you fail the knowledge test, you have the option of reapplying for a licence.</li> </ul>
