Voraussetzungen	
Kosten	For persons entitled under the Federal Expellees Act, the recognition of examinations or certificates of qualification is free of charge if the application is submitted within three years of the start of permanent residence in the Federal Republic. Otherwise, a fee of EUR 20.00 to EUR 60.00 will be charged for the examination and processing of the application, depending on the fee tariff of the responsible IHK.
