	 The authority will confirm receipt of the application and inform you of any documents that may still be missing. In the event of a positive examination, the licence to practise medicine will be issued and handed over to you against acknowledgement of receipt or sent to you by post.
Bearbeitungsdauer	 Application processing: up to three months after complete submission of the application documents Examination of substantial differences ("equivalence examination") for applicants from third countries: generally up to four months after submission of the complete documents and expert opinions **Note:** Especially if an expert is consulted, the processing time may be considerably longer.
