- Vocational training relationships with regional or personal corporations under public law as well as with companies in which regional or personal corporations under public law hold the majority of capital shares
- Subsidies for courses of inter-company instruction in the skilled trades take precedence over this subsidy.

Subsidy per training week and participant: EUR 150.00 (A training week is based on five training days which do not have to be completed consecutively. However, only full participant weeks are funded. If no full participant weeks are completed, the number is rounded down to the full participant week)

Companies (natural or legal persons, associations of persons) with up to 500 employees with their registered office or branch in the Free State of Saxony which send trainees to the association partner within the framework of the training contract

Funding requirements

Funding is possible if





Sachverhalt

- the training relationships are in-company vocational training relationships
- the vocational training is carried out in recognised training occupations under the Vocational Training Act or the Crafts Code and the training course meets the requirements of section 1(3) of the Vocational Training Act (BBiG)
- the training contract is entered in the register of vocational training relationships at the time of application

The State Office for the Environment, Agriculture and Geology must confirm that these requirements are met.

As a first step, take advantage of the advisory services offered by the Sächsische Aufbaubank - Förderbank - (SAB). You can apply for funding online at the SAB funding portal.

application:

- You fill out your application online and an electronic assistant guides you through the process.
- Once you have completed the entry, the SAB will send you a confirmation e-mail containing your application and a summary of all the information you have entered.
- Please print out the application, sign it and submit it together with the required attachments to the State Office for the Environment, Agriculture and Geology (LfULG) for forwarding to the SAB.
- After the SAB has examined the application, you will receive a decision as to whether your project will be funded and, if so, how much.
