Verfahrensablauf	<p>You can apply for integration assistance after making an appointment at the competent office, in writing by post or fax, or informally by e-mail. Take advantage of the counselling services offered by the Kommunalen Sozialverband Sachsen (KSV) and the independent counselling centres (EUTB).</p> <p>The application can be made by</p> <ul style="list-style-type: none"> • You personally, • Your representative with power of attorney • Your legal representative. <p>Once the application has been submitted, the designated overall plan procedure will be carried out. Within the framework of the overall plan procedure, the individual needs in particular will also be determined.</p>
