	One document that serves as proof is the "Form Z". On this form, you must have the competent department confirm that you meet the professional admission requirements for the examination or can meet them by the time of the examination.
	 The competent department for IHK occupations is the Chamber of Industry and Commerce (Industrie- und Handelskammer/IHK) You usually qualify either by having completed your first professional training and/or through initial work experience. Even if you have dropped out of university, have professional experience or have a Bachelor's degree, you can prove that you have the required prior qualification. The exact requirements are set out in the examination regulations for the respective continuing

	Note: After confirming this pre-qualification, you can apply for the so-called "Meister-BAföG". Depending on the federal state, BAföG offices or other authorities are responsible for this.
