Are you building or expanding wastewater treatment plants?

The expenses incurred by you can be offset against the waste water levy you paid for the discharges concerned in the previous three calendar years.
Prerequisite: The plant operation can be expected to

- a 20 percent reduction in the load of a fee-relevant parameter in the waste water stream to be treated
- a reduction in the total pollutant load

This also applies to the construction of so-called influent plants, provided that an overall reduction in

Voraussetzungen	<p>Anyone who discharges waste water into a body of water within the meaning of section 3 numbers 1 to 3 of the Water Resources Act (Wasserhaushaltsgesetz/(WHG)) is liable to pay the fee.</p> <p>Excluded from this are dischargers who discharge less than 8 m³ per day of waste water from households and similar waste water, in which case the public corporation responsible for waste water disposal is liable to pay the fee.</p> <p>The prerequisite for an application for offsetting in accordance with § 10 paragraph 3 of the Waste Water Fee Act (Abwasserabgabengesetz/(AbwAG)) is that there is an obligation to pay the waste water fee and that the following conditions are met:</p> <ul style="list-style-type: none"> • Expenditure on the construction or extension of the waste water treatment plant • 20% reduction in the load of a fee-relevant parameter (listed in the annex to AbwAG) in the waste water stream to be treated • Reduction of the total pollutant load discharged into the watercourse <p>The prerequisite for an application for offsetting under Article 10(4) AbwAG is that there is an obligation to pay the waste water fee and that the following conditions are met:</p> <ul style="list-style-type: none"> • Expenditure on the construction of facilities which convey the waste water of existing discharges to a waste water treatment plant • Reduction of the total pollutant load discharged
