Erforderliche Unterlagen	• Current identity card or passport • Registration certificate I (old: vehicle registration certificate) • Certificate of use if the applicant is not the vehicle owner • power of attorney • if the application is made by a representative Further documents may be required.
Voraussetzungen	• You are registered in the residents' parking area and you actually live there • there is no private parking space available • the vehicle is registered to you as the owner or you can prove that you use the vehicle permanently. Please note: The requirements may vary depending on the responsible
Kosten	10.20 € to 30.70 € per year in accordance with Section 1 (1) of the Fee Regulations for Road Traffic Measures (GebOSt) in conjunction with Fee No. 265 of the Annex (to Section 1)
Verfahrensablauf	It is best to go in person to the road traffic authority responsible for you and present the documents there. As a rule, this should be the public order office of your municipality if it is a municipal street. Some road traffic authorities also allow you to apply

	for a resident parking permit in writing or electronically. Ask your local authority what documents you need to send in this case. In some cases you will then receive the parking permit by post, in others you will have to collect it on site.
Bearbeitungsdauer	Please ask your local road traffic authority about the processing time, as this varies from authority to authority and may differ depending on the type of application (in person or online).
Frist	The resident parking permit is limited in time.
