Teaser	<p>As the owner or operator of a telecommunications line, you require the consent of the landowner to lay or modify this infrastructure. If the property is a public highway, you must submit the application to the responsible highway authority.</p> <p>The link to the application portal is available to telecommunications companies and their service providers.</p>
Volltext	<p>If you are the owner or operator of a telecommunications line or a telecommunications network serving public purposes, you require the consent of the landowner to relocate or modify this infrastructure. If the property is a public traffic route, you must submit the application to the road owner. With the approval of the road owner, you can obtain any other necessary permits.</p> <p>Once you have obtained all the necessary permits, you can generally start the construction work. more and more places. Its use offers the following advantages:

- Clear presentation of your submitted applications and resubmission function
- Provision of standardized formulations for statements and conditions
- Direct communication option with the responsible authority
- Interface option for integration into your own system environment, specialist procedures and GIS systems
- Early coordination of restrictions or principles (installation guidelines) that the competent authority wishes to be observed during implementation
- Early communication between the responsible authority and the telecommunications company (TKU) regarding the most effective route planning possible
- All notifications and documents can be processed in digital form, thus ensuring seamless processing. This shortens response times, which means that the focus is on actual and widespread implementation.

For you as a company in the telecommunications industry, the digitized application process means a considerable simplification. The telecommunications company or service provider submitting the application is guided by the standardized application form so that relevant aspects can be transmitted easily. All notifications and documents are processed in digital form, thus ensuring seamless processing. The functional addresses set up ensure that applications are routed in a targeted manner or assigned to the relevant departments. This shortens response times and you will receive an answer to your request in a short time. This should also speed up the approval process.

- Map or geodata with exact location of the measure
- Precise description of the measure (e.g. the components to be installed, information on quantities, masses and installation depth, time of implementation)
- Right of way from the Federal Network Agency

- The infrastructure manager has the option of attaching ancillary conditions to the approval, which you must take into account when implementing the measure.
- The approval will be sent to you within 3 months of the application being submitted.
- This period may be extended by one month if the application is more difficult. You will be informed of this.
- If you have not received a notice of approval after three months, your application is deemed to have been approved.

You can apply for line relocations in writing or online. The process begins with the application and ends with the notice of approval from the infrastructure manager and its digital provision. You can also submit a preliminary request first.

- As a telecommunications company or service provider, you submit your "Application for cable laying" via our website under the "Service" section and submit further documents here if necessary.
- The application is submitted via the specified functional addresses.
- Information on the implementation of the construction measure and the location/location must be entered.
- You must show the route of the pipeline on informative plans and attach them to your application in digital form.
- You can also enclose other documents relating to the construction project in digital form or in free form in your e-mail.
- The infrastructure manager will process the application.
- The approval notice will be sent to the telecommunications company or service provider by e-mail.
