Teaser	<p>If you are moving house or carrying out or expecting deliveries and collections, you can apply for a temporary no-stopping zone.</p> <p>Here you will find information on setting up a no-stopping zone, e.g. for your move.</p>
Volltext	<p>You can apply for a no-stopping zone. This is limited in time. You can apply for a no-stopping zone for removals or for loading and unloading.</p> <p>The application for a temporary no-stopping zone must be made in writing and informally to the competent authority. The application must include the location, period and length of the desired no-stopping zone. This depends on the length of the vehicle used for the move. For more information on the regulations in your municipality, you can select your city/municipality in the menu.</p>

Verfahrensablauf	<p>You can submit the application in writing by means of an informal application.</p> <ul style="list-style-type: none"> • The application will be reviewed by the competent authority. • If the result is positive, you will receive a permit and a road traffic order from the competent authority to erect the required traffic signs. • Important for the application are <ul style="list-style-type: none"> • the location • the time period • the length in meters • the length depends on the vehicle used • Surname, first name, address and telephone number of the person responsible
Bearbeitungsdauer	Processing usually takes place immediately or promptly.
Frist	<p>Deadline type: Duration (for span): 14 days Note: The application must be submitted at least 14 days in advance, as the traffic signs for the residents must be put up 3 days in advance. Type of deadline: Duration (for span): limited in time Note: The permit is only valid for the period specified on the order.</p>

Hinweise	<p>The required traffic signs must be erected at least three days before the no stopping zone is used. The traffic signs may only be erected after the permit has been received.</p> <p>Only traffic signs in accordance with the German Road Traffic Regulations (StVO) may be erected.</p>

The traffic signs must be erected by certified specialist personnel, for example by a specialist company for traffic safety.

The installation must be recorded in an installation log. The time and exact location of the installation must be noted there.

In the event of damage, the persons submitting the application may be liable.

Third-party vehicles in the established no-parking zone can be removed.

Additional measures must be specified in the application, for which additional permits may be required (e.g. a special use application for containers).

You will need a separate order for the move-in and move-out locations.

It is not advisable to block off a parking space with lines, tapes, cardboard boxes or chairs. Other people looking for a parking space can and may move these obstacles aside and park. The police also intervene when they see such barriers. A warning or fine is then often imposed.

The signs must be removed at the end of the move or delivery and collection.
