Teaser	If you wish to extend the validity of your resident parking permit, you must apply to the relevant authority.
Volltext	In order to extend the validity of the resident parking permit for your vehicle in a special zone in good time, you must submit an application for an extension to the relevant road traffic authority in your place of residence before the current permit expires. The permit allows you to continue to park your vehicle in your urban residential area with considerable parking pressure. Make sure that you submit the application for renewal in good time to ensure uninterrupted use of the reserved parking spaces.
Erforderliche Unterlagen	• Application for renewal of the resident parking permit • Current proof of identity (e.g. identity card or passport) • If applying through a representative Power of attorney • Proof of continued vehicle use (e.g. vehicle registration document) • Registration certificate of the current residential address
Voraussetzungen	• You have a resident parking permit. • You are still registered in the relevant resident parking area. • The vehicle is registered to you or is permanently used by you.
