Hinweise	A complete building application is essential for the procedure to run smoothly. If a building is to be erected or a change is to be made to a building, you will need a design drafter who is authorized to submit building documents. If you are modifying or constructing a structure that is not a building, you do not require a building permit. In the case of a pure change of use without a structural change, a design author can be dispensed with entirely. The author of the design, who is authorized to submit building plans, is usually an architect or a civil engineer. If there are any doubts about the basic approvability of the building project, you can have these clarified at an early stage with a preliminary building permit. However, this only answers individual questions and does not replace the required building permit.

	Advice outside of ongoing approval procedures is subject to a charge.
