Hinweise	If the notification of the start of construction is not submitted or not submitted on time, this may be punished as an administrative offense.
Rechtsbehelf	
Kurztext	At least one week before the start of construction, the start of construction must be notified to the responsible building authority in accordance with Section 73 of the State Building Code and the responsible persons must be named in accordance with Section 53 of the State Building Code.
	At least one week before the start of construction, the start of construction must be notified to the responsible building authority and those responsible must be named in accordance with § 53 LBO.
