Teaser	Have you been granted an exemption permit for a trade requiring a license and want to operate it as a standing trade? If so, you must have it entered in the register of craftsmen before starting your activity.
Volltext	 The Register of Craftsmen is a register in which all natural persons partnerships and legal entities who operate a craft requiring a license as a standing trade. Itinerant trades and market trades do not count as standing trades. You can find a complete list of trades requiring a license in Appendix A of the Crafts Code (HwO). The trade does not have to be exercised as a whole, as the exercise of essential (partial) activities is also possible. Conversely, it is conceivable that several trades or

essential activities of several trades are to be practiced.

Furthermore, the business manager who is responsible for the professional and technical management of the craft business and who has the necessary professional qualification to practice the craft requiring a license is entered in the Register of Craftsmen. Both the owners of craft businesses and employed persons are eligible as managers. Proof of qualification is provided by submitting the notice of exemption issued for the respective craft or related craft to be practiced.

Erforderliche Unterlagen

For sole proprietorships:

- Identity card or comparable identification document (copy)
- Notice of the granted exemption permit (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For companies under civil law (GbR):

- Identity card or comparable identification document of the partners (copy)
- Articles of association, if not concluded informally (copy)
- Notification of the exemption permit issued to the personally liable partner responsible for the technical management of the business or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the trade register

For commercial partnerships entered in the commercial register:

For companies based in Germany:

- for companies entered in the commercial register: extract from the register, articles of association (copy)

- Notification of the exemption granted to the personally liable partner responsible for the technical management of the business or the partner or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For foreign legal forms:

- Extract from the register, if already entered in the foreign register, articles of association (copy)
- Notification of the granted exemption permit of the personally liable partner responsible for the technical management of the business or the partner or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

- Limited liability company (GmbH)
- Entrepreneurial company (limited liability)
- public limited company (AG)
- registered cooperative (eG)
- Identity card or comparable identification document of the authorized representatives (copy)
- for companies based in Germany: extract from the register, articles of association (copy)
- for foreign legal forms: Register excerpt from the relevant foreign register, articles of association (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen
- Details of the company management
- Notification of the exemption permit granted to the employed management

If you employ a manager, you must also submit the following information

- Plant manager's declaration
- Employment contract (copy)
- Proof of social insurance for the manager (copy)
- Notification of the granted exemption permit (copy)

If you employ a second person as a manager, you must also submit the manager's declaration and the other documents mentioned for this person. This may be the case, for example, if you wish to carry out several trades requiring a license as a permanent business.

Voraussetzungen

You, the personally liable partner responsible for the technical management of the company or your company management require an exemption permit

• in the craft requiring a license or
• in a craft related to this craft
with which you wish to become self-employed in a standing trade.
The amount of the fees can be found in the fee schedule of the responsible Chamber of Crafts.
You can apply for entry in the Register of Craftsmen in writing or, in some cases, online at your local Chamber of Crafts. Please contact the relevant Chamber of Skilled Crafts for information on the procedure. You can also have the necessary documents sent to you.
 Submit your application documents to your local Chamber of Skilled Crafts
• The Chamber of Skilled Crafts will check your application for completeness
 Once you have been registered, you will receive a written certificate from your local Chamber of Skilled Crafts. Your company will receive the so-called craftsman's card
• If the registration is rejected, you will receive a notification from the local Chamber of Skilled Crafts
If all documents are complete and no further procedure is necessary, the Chamber of Skilled Crafts must make the entry in the Register of Skilled Crafts within 3 months, otherwise the entry is deemed to have been made after this period has expired. Processing time: 3 months
You must be entered in the Register of Craftsmen before starting work.

	• Depending on the federal state in which you have submitted the application, a preliminary procedure will be carried out first
	 Please refer to the instructions on legal remedies in your notification for information on existing legal remedies

	• Register of craftsmen as a register of all owners of a business of a craft requiring a license in a standing trade
	 Registration concerns natural persons partnerships and legal entities Legal obligation to register: all business owners with a craft requiring a license in a standing trade must be registered in the craft register
